

## 2022 CITIZENS BANK HOLIDAY HUNT RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

- 1. Eligibility:** This Campaign is open only to those 18 years of age or older as of the date of entry. The Campaign is only open to legal residents of the State of Wisconsin in Waukesha, Walworth, Racine, Milwaukee, or Jefferson Counties and is void where prohibited by law. No person who has entered and won a contest sponsored by Citizens Bank in the last one hundred eighty (180) days is eligible to win again. Employees of Citizens Bank, its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Campaign. - 4. How to Enter:** The Campaign may be entered by obtaining an official Campaign stamp card from any Citizens Bank location, the Citizens Bank website, or a participating retailer. The Contestant must collect stamps from at least three (3) different businesses featured on the stamp card to be entered into a random drawing to advance to the final round. The entry must fulfill all Campaign requirements and be submitted within the Campaign period, as specified, for entry into the drawing.
